## **Gillian Easson**



Gillian Easson is the director of Creative Dundee in Scotland, where she designs a diverse portfolio of projects in collaboration with the team, and leads strategic partnerships which support the sustainability of creative communities. Gillian has grown Creative Dundee from the ground up since starting it as a blog in 2008, by catalysing opportunities for people and their place. With a background in design and innovation, she has used this to improve access routes to education, employment and enterprise. Gillian has worked extensively

internationally, sharing strategies and practical tools which value the broader impacts of creative clusters and networked approaches. Equally happy facilitating workshops, or navigating complex multi-partner projects, she is a fan of the messiness, embracing open and collective ways of working, to find the ultimate murmuration.

#### Patricia Mendoza



Patricia Mendoza is a Cebuana managing MATIC Hub, an enabling space for Cebu's creative community, while heading the University of Cebu's Animation Department with a goal to produce work-ready animators. ## Tuukka Toivonen, PhD



Tuukka Toivonen is the Director of Creative Friction Ltd currently based in Japan. He is a creative community strategist as well as a scholar of entrepreneurship, coworking and social innovation at University College London. His firm Creative Friction helps organisations build flourishing communities at a time when many innovative spaces struggle to adequately connect, empower and inspire their diverse members. Tuukka also regularly mentors creative

hub leaders, founders and ambitious community managers.

## John Newbigin OBE



John Newbigin OBE is the Ambassador for the Creative Industries at the Mayor of London. He is the co-founder and Chair of Creative England. He was previously the chair for RSA (Royal Society for the encouragement of Arts, Manufactures and Commerce) network Screen England and is a freelance journalist and strategic consultant for the creative industries. John serves on a number of boards including Culture 24, an online gateway to the UK's cultural sector. He is a

Visiting Professor at the University of East London and other international universities, and a Member of the British Council's Advisory Board for Arts and Creative Industries. He was awarded an OBE for services to creative industries and the arts in 2015.

### **Benjamin Milton Hampe**



Benjamin Milton Hampe is currently the project director of ASEAN Foundation currently based in Singapore. His work with ASEAN started in 2017 when he organised ASEAN's 50 year anniversary exhibition at the ASEAN Gallery. Since then he has provided ongoing strategic planning, curatorial, and training services for the ASEAN Gallery and Collection. In 2020 he was appointed Project Director of KONNECT ASEAN, a development project supported by the Republic

of Korea and the ASEAN Foundation's core arts and cultural programme. In addition to over 15 years as a consultant he has served in leadership roles for a private museum and commercial art galleries and art fairs. He is Burmese/Australian and lives in Singapore.

### Congressman Christopher Vera Perez de Venecia



Congressman Christopher Vera Perez de Venecia finished his elementary studies at the Colegio de San Agustin and his secondary education at the Ateneo de Manila High School. He has a bachelor's degree in Political Science at the Ateneo de Manila University. He recently finished courses in Public Leadership at Harvard Kennedy School. He was the former lifestyle editor of CHALK Magazine and previously the editor of the Philippine Star's Youth Section. He is a

proud millennial with a background in theater arts and communication having started two of Manila's foremost theater companies - 9 Works Theatrical and The Sandbox Collective.

At present, he is the Representative of the 4th District of Pangasinan in the Lower House, sitting as the Deputy Majority Leader. He is also the Chairman of the Special Committee on Creative Industry and Performing Arts. In addition, he is also a member of numerous committees, notably the Committee on Basic Education and Culture and Committee on Tourism to promote his culture and tourism advocacies. He is also the lead convener of the 55-member Arts and Culture and Creative Industries Bloc of the 18th Congress, with eleven (11) Deputy Speakers and fourteen (17) Committee Chairmen as members, which seeks to introduce and support legislations that protect, promote, and bolster arts, culture, and the creative industries. He has authored the Magna Carta for Young Farmers, Integrated Urban Agriculture Act, Eddie Garcia Act, Freelancers Protection Act, Film Philippines Bill, Fund Our Museums Acts of 2020 and the Philippine Music Industry Act of 2020, among others. With the rigor of both his parliamentary work and his constituency work in the district, he advocates for multi-sectoral collaboration and the expansion of livelihood in the rural countryside through various forms of tourism and agricultural modernization, as well as galvanizing culture for both economic growth and nation building.

### Dr Dina Dellyana, PhD



Dr Dina Dellyana is the Coordinator of Global Center of Excellence and International Cooperation for Creative Economy Indonesia. She is a lecturer and business incubator director at the School of Business and Management, Institut Teknologi Bandung (SBM ITB) and head of entrepreneurship development division in LPIK ITB. She is actively involved in several startup development activities as she also become a Mentor in Indigo Creative Nation, Startup development division in MIKTI and head of startup development in west Java's Chambers of Commerce. She's also actively

conducting research with topics on Business Model Innovation, SME Development, Business Incubator and Social Media and E-commerce for SME's. She written many articles for accredited international journals and several book chapters, including the "Routledge Handbook of Cultural and Creative Industry in Asia"

### Malaya del Rosario



Malaya del Rosario is a cultural strategy and art management specialist based in Manila. She has 15 years of experience in exhibition and project management, and partnerships development in Asia and Europe. She has led programmes with teams of over 30 members.
