1 Overview of the British Council

The British Council is the UK's international organisation for cultural relations and educational opportunities. We create friendly knowledge and understanding between the people of the UK and other countries. We do this by making a positive contribution to the UK and the countries we work with – changing lives by creating opportunities, building connections and engendering trust.

- 1.2 We work with over 100 countries across the world in the fields of arts and culture, English language, education and civil society. Each year we reach over 20 million people face-to-face and more than 500 million people online, via broadcasts and publications. Founded in 1934, we are a UK charity governed by Royal Charter and a UK public body

2 Introduction and Background to the Project / Programme

This research in the Philippines is part of a wider British Council-led programme of research on the creative economy across South East Asia. The purpose of this research programme is to:

- a) Generate new, engaging and relevant evidence on the creative economy in Southeast Asia
- b) Test and develop new effective research methodologies which help to improve baseline understanding of sector trends and the impact of interventions

- c) Generate new detailed, relevant and transferable evidence on specific policy and partnership activities (focus areas) which are seen as of strategic importance in each country
- d) Build new and sustainable partnerships with SEA and UK research experts in universities, consultancies, municipalities etc.
- e) Share evidence and approaches at a regional and international level to build new channels of professional knowledge exchange and mutuality.
- f) Build long-term strategic relations with the UK.

The British Council's creative economy work in the Philippines

The British Council is an integral and important part of the UK's bilateral relationship with the Philippines.

Within this diverse environment and a boom of creative entrepreneurs, British Council Philippines is developing a range of research and development activities to increase level of engagement and support towards creative hubs and promote a wider recognition of the value of the creative industries by communities, enabling high degree of influence on urban, city, local government and national policies.

In recent years, both public and private sector partners have begun to develop a strategic approach to the creative economy. The British Council has played an active enabling and supporting role. This includes indepth creative industries mapping in Baguio and Makati, which is providing information on the development needs of creative businesses in these cities. It also includes high level strategic partnership work with the Department of Trade and Industry (DTI) and National Commission for Culture and the Arts (NCCA). With the former, this has included the establishment of a national Creative Economy Programme Partnership, which is championing sector development; plus a set of targeted events and development activities for key sectors such as Design and in priority cities such as Cebu. However, overall there is a lack of data and evidence on the creative economy in the Philippines. There is also little primary evidence on the role, impact and development trajectory of creative hubs.

In the 2017 study, the Philippine Creative Economy: Toward a Baseline, Tom Fleming writes:

"The lack of consistent, robust high quality data and inadequate data collection systems mean The Philippines does not have a detailed and accurate baseline for the Creative Industries. In turn, this means policy and investment is less informed by evidence than in other countries; that commercial investors remain unconvinced of the scalable potential of the sector; and that The Philippines can't be benchmarked at a regional or global level."

A new regional Creative Economy research programme for Southeast Asia

The research on creative hubs in the Philippines will be part of a wider regional research programme for Southeast Asia (SEA). The selected local researcher and/or team in the Philippines will be expected to work closely with a UK-based researcher counterpart, and as part of a wider research partnership operating across four research projects in four countries: Thailand, Indonesia, Malaysia and the Philippines.

The outputs of this wider research programme, into which the research in the Philippines will input are as follow:

- Detailed understanding of a set of focus areas which have been identified as key policy and partnership activities in the creative economy of each country
- Research partnerships with local and UK experts (in academia, consultancy etc) to build mutual knowledge exchange and shape sustainable partnerships
- Extensive evidence of the impact of specific interventions such as creative districts and hubs, networks, partnership and investment.
- Case studies on good practice, lessons learned, innovation and future opportunities
- A set of shared learning points and considerations for exchange at a regional and international level
- Literature and synthetic review reports to provide context for the above focus research highlighting what is known about creative economy in the four countries and the strength of existing evidence of the British Council, local and international partners' work in this area.
- Programme of knowledge sharing events / platforms. With each project sharing knowledge as
 it is developed, underpinned by theory of change frameworks for each project.
- Final summary reports and recommendations for future approaches to strategic research and partnership working in SEA to be commissioned separately and presented at the end of the research programme.

The services expected from the researcher for the project in the Philippines will be delivered as part of a team with a UK-based partner. This partner will be procured directly by the British Council and then introduced to the selected local researcher.

The appointed researcher will be expected to work with the UK-based researcher to investigate and measure the social impact that two creative hubs have on their communities, particularly, Pineapple Lab in Makati City (part of Metro Manila), and Anthill Fabric Gallery in Cebu City, Philippines. Additionally, the research will generate insights and a strategic overview of the role, position and social impact of creative hubs based on an existing database of 84 creative hubs that applied to British Council's Creative Innovators Programme in the Philippines. The database includes information on the hubs' mission and vision, size, programming, ambitions, opportunities and challenges.

3 Tender Conditions and Contractual Requirements

This section of the RFP sets out the British Council's contracting requirements, general policy requirements, and the general tender conditions relating to this procurement process ("**Procurement Process**").

3.1 Contracting requirements

- 3.1.1 The contracting authority is the British Council which includes any subsidiary companies and other organisations that control or are controlled by the British Council from time to time (see: http://www.britishcouncil.org/organisation/structure/status).
- 3.1.2 The appointed supplier will be expected to deliver the goods and/or provide services at the British Council offices in the Philippines.
- 3.1.3 The British Council's contracting and commercial approach in respect of the required goods and/or services is set out at Annex 1 (Terms and Conditions of contract) ("Contract"). By submitting a tender response, you are agreeing to be bound by the terms of this RFP and the Contract without further negotiation or amendment.
- 3.1.4 The Contract awarded will be for a duration of **six months**, **from August 2019 until February 2020**, with an option for an extension for up to an additional one month.
- 3.1.5 In the event that you have any concerns or queries in relation to the Contract, you should submit a clarification request in accordance with the provisions of this RFP by the Clarification Deadline (as defined below in the Timescales section of this RFP). Following such clarification requests, the British Council may issue a clarification change to the Contract that will apply to all potential suppliers submitting a tender response.
- 3.1.6 The British Council is under no obligations to consider any clarifications / amendments to the Contract proposed following the Clarification Deadline, but before the Response Deadline (as defined below in the Timescales section of this RFP). Any proposed amendments received from a potential supplier as part its tender response shall entitle the British Council to reject that tender response and to disqualify that potential supplier from this Procurement Process.

3.2 General Policy Requirements

3.2.1 By submitting a tender response in connection with this Procurement Process, potential suppliers confirm that they will, and that they shall ensure that any consortium members and/or subcontractors will, comply with all applicable laws, codes of practice, statutory guidance and applicable British Council policies relevant to the goods and/or services being supplied. All relevant British Council policies that suppliers are expected to comply with can be found on the British Council website (https://www.britishcouncil.org/organisation/transparency/policies). The list of relevant policies includes (but it is not limited to): Anti-Fraud and Corruption, Child Protection Policy, Equality, Diversity and

Inclusion Policy, Fair Trading, Health and Safety Policy, Environmental Policy, Records Management, and Privacy.

3.3 General tender conditions ("Tender Conditions")

- 3.3.1 <u>Application of these Tender Conditions</u> In participating in this Procurement Process and/or by submitting a tender response it will be implied that you accept and will be bound by all the provisions of this RFP and its Annexes. Accordingly, tender responses should be on the basis of and strictly in accordance with the requirements of this RFP.
- 3.3.2 <u>Third party verifications</u> Your tender response is submitted on the basis that you consent to the British Council carrying out all necessary actions to verify the information that you have provided; and the analysis of your tender response being undertaken by one or more third parties commissioned by the British Council for such purposes.
- 3.3.3 <u>Information provided to potential suppliers</u> Information that is supplied to potential suppliers as part of this Procurement Process is supplied in good faith. The information contained in the RFP and the supporting documents and in any related written or oral communication is believed to be correct at the time of issue but the British Council will not accept any liability for its accuracy, adequacy or completeness and no warranty is given as such. This exclusion does not extend to any fraudulent misrepresentation made by or on behalf of the British Council.
- 3.3.4 <u>Potential suppliers to make their own enquires</u> You are responsible for analysing and reviewing all information provided to you as part of this Procurement Process and for forming your own opinions and seeking advice as you consider appropriate. You should notify the British Council promptly of any perceived ambiguity, inconsistency or omission in this RFP and/or any in of its associated documents and/or in any information provided to you as part of this Procurement Process.
- 3.3.5 <u>Amendments to the RFP</u> At any time prior to the Response Deadline, the British Council may amend the RFP. Any such amendment shall be issued to all potential suppliers, and if appropriate to ensure potential suppliers have reasonable time in which to take such amendment into account, the Response Deadline shall, at the discretion of the British Council, be extended.
- 3.3.6 <u>Compliance of tender response submission</u> Any goods and/or services offered should be on the basis of and strictly in accordance with the RFP (including, without limitation, any specification of the British Council's requirements, these Tender Conditions and the Contract) and all other documents and any clarifications or updates issued by the British Council as part of this Procurement Process.

- 3.3.7 <u>Format of tender response submission</u> Tender responses must comprise the relevant documents specified by the British Council completed in all areas and in the format as detailed by the British Council in Annex 2 (Supplier Response). Any documents requested by the British Council must be completed in full. It is, therefore, important that you read the RFP carefully before completing and submitting your tender response.
- 3.3.8 <u>Modifications to tender response documents once submitted</u> You may modify your tender response prior to the Response Deadline by giving written notice to the British Council. Any modification should be clear and submitted as a complete new tender response in accordance with Annex 2 (Supplier Response) and these Tender Conditions.
- 3.3.9 <u>Rejection of tender responses or other documents</u> A tender response or any other document requested by the British Council may be rejected which:
 - contains gaps, omissions, misrepresentations, errors, uncompleted sections, or changes to the format of the tender documentation provided;
 - contains hand written amendments which have not been initialled by the authorised signatory;
 - does not reflect and confirm full and unconditional compliance with all of the documents issued by the British Council forming part of the RFP;
 - contains any caveats or any other statements or assumptions qualifying the tender response that
 are not capable of evaluation in accordance with the evaluation model or requiring changes to any
 documents issued by the British Council in any way;
 - is not submitted in a manner consistent with the provisions set out in this RFP;
 - is received after the Response Deadline.
- 3.3.10 <u>Disqualification</u> If you breach these Tender Conditions, if there are any errors, omissions or material adverse changes relating to any information supplied by you at any stage in this Procurement Process, if any other circumstances set out in this RFP, and/or in any supporting documents, entitling the British Council to reject a tender response apply and/or if you or your appointed advisers attempt:
 - to inappropriately influence this Procurement Process;
 - to fix or set the price for goods or services;
 - to enter into an arrangement with any other party that such party shall refrain from submitting a tender response;
 - to enter into any arrangement with any other party (other than another party that forms part of your consortium bid or is your proposed sub-contractor) as to the prices submitted; or
 - to collude in any other way
 - to engage in direct or indirect bribery or canvassing by you or your appointed advisers in relation to this Procurement Process; or

- to obtain information from any of the employees, agents or advisors of the British Council concerning this Procurement Process (other than as set out in these Tender Conditions) or from another potential supplier or another tender response, the British Council shall be entitled to reject your tender response in full and to disqualify you from this Procurement Process. Subject to the "Liability" Tender Condition below, by participating in this Procurement Process you accept that the British Council shall have no liability to a disqualified potential supplier in these circumstances.
- 3.3.11 <u>Tender costs</u> You are responsible for obtaining all information necessary for preparation of your tender response and for all costs and expenses incurred in preparation of the tender response. Subject to the "Liability" Tender Condition below, you accept by your participation in this procurement, including without limitation the submission of a tender response, that you will not be entitled to claim from the British Council any costs, expenses or liabilities that you may incur in tendering for this procurement irrespective of whether or not your tender response is successful.
- 3.3.12 Rights to cancel or vary this Procurement Process By issuing this RFP, entering into clarification communications with potential suppliers or by having any other form of communication with potential suppliers, the British Council is not bound in any way to enter into any contractual or other arrangement with you or any other potential supplier. It is intended that the remainder of this Procurement Process will take place in accordance with the provisions of this RFP but the British Council reserves the right to terminate, amend or vary (to include, without limitation, in relation to any timescales or deadlines) this Procurement Process by notice to all potential supplier in writing. Subject to the "Liability" Tender Condition below, the British will have no liability for any losses, costs or expenses caused to you as a result of such termination, amendment or variation.
- 3.3.13 <u>Consortium Members and sub-contractors</u> It is your responsibility to ensure that any staff, consortium members, sub-contractors and advisers abide by these Tender Conditions and the requirement of this RFP.
- 3.3.14 <u>Liability</u> Nothing in these Tender Conditions is intended to exclude or limit the liability of the British Council in relation to fraud or in other circumstances where the British Council's liability may not be limited under any applicable law.

4 Confidentiality and Information Governance

4.1 All information supplied to you by the British Council, including this RFP and all other documents relating to this Procurement Process, either in writing or orally, must be treated in confidence and not disclosed to any third party (save to your professional advisers, consortium members and/or subcontractors strictly for the purposes only of helping you to participate in this Procurement Process and/or prepare your tender response) unless the information is already in the public domain or is required to be disclosed under any applicable laws.

- 4.2 You shall not disclose, copy or reproduce any of the information supplied to you as part of this Procurement Process other than for the purposes of preparing and submitting a tender response. There must be no publicity by you regarding the Procurement Process or the future award of any contract unless the British Council has given express written consent to the relevant communication.
- 4.3 This RFP and its accompanying documents shall remain the property of the British Council and must be returned on demand.
- 4.4 The British Council reserves the right to disclose all documents relating to this Procurement Process, including without limitation your tender response, to any employee, third party agent, adviser or other third party involved in the procurement in support of, and/or in collaboration with, the British Council. The British Council further reserves the right to publish the Contract once awarded and/or disclose information in connection with supplier performance under the Contract in accordance with any public sector transparency policies (as referred to below). By participating in this Procurement Process, you agree to such disclosure and/or publication by the British Council in accordance with such rights reserved by it under this paragraph.
- 4.5 The Freedom of Information Act 2000 ("FOIA"), the Environmental Information Regulations 2004 ("EIR"), and public sector transparency policies apply to the British Council (together the "**Disclosure Obligations**").
- 4.6 You should be aware of the British Council's obligations and responsibilities under the Disclosure Obligations to disclose information held by the British Council. Information provided by you in connection with this Procurement Process, or with any contract that may be awarded as a result of this exercise, may therefore have to be disclosed by the British Council under the Disclosure Obligations, unless the British Council decides that one of the statutory exemptions under the FOIA or the EIR applies.
- 4.7 If you wish to designate information supplied as part of your tender response or otherwise in connection with this tender exercise as confidential, using any template and/or further guidance provided at Part 2 (Submission Checklist) of Annex 2 (Supplier Response), you must provide clear and specific detail as to:
 - the precise elements which are considered confidential and/or commercially sensitive;
 - why you consider an exemption under the FOIA or EIR would apply; and
 - the estimated length of time during which the exemption will apply.

- 4.8 The use of blanket protective markings of whole documents such as "commercial in confidence" will not be sufficient. By participating in this Procurement Process you agree that the British Council should not and will not be bound by any such markings.
- In addition, marking any material as "confidential" or "commercially sensitive" or equivalent should not be taken to mean that the British Council accepts any duty of confidentiality by virtue of such marking. You accept that the decision as to which information will be disclosed is reserved to the British Council, notwithstanding any consultation with you or any designation of information as confidential or commercially sensitive or equivalent you may have made. You agree, by participating further in this Procurement Process and/or submitting your tender response, that all information is provided to the British Council on the basis that it may be disclosed under the Disclosure Obligations if the British Council considers that it is required to do so and/or may be used by the British Council in accordance with the provisions provision of this RFP.
- 4.10 Tender responses are also submitted on the condition that the appointed supplier will only process personal data (as may be defined under any relevant data protection laws) that it gains access to in performance of this Contract in accordance with the British Council 's instructions and will not use such personal data for any other purpose. The contracted supplier will undertake to process any personal data on the British Council's behalf in accordance with the relevant provisions of any relevant data protection laws and to ensure all consents required under such laws are obtained.

5 Tender Validity

5.1 Your tender response must remain open for acceptance by the British Council for a period of sixty days from the Response Deadline. A tender response not valid for this period may be rejected by the British Council.

6 Payment and Invoicing

- 6.1 The British Council will pay correctly addressed and undisputed invoices within 30 days in accordance with the requirements of the Contract. Suppliers to the British Council must ensure comparable payment provisions apply to the payment of their sub-contractors and the sub-contractors of their sub-contractors. General requirements for an invoice for the British Council include:
 - A description of the good/services supplied is included.

7 Specification

The Philippines research project: Creative Hubs

This research will undertake situation analysis on the development of creative hubs in the Philippines with two in-depth case studies and a broader analysis of the role and positioning of creative hubs within the wider creative economy. The two main research questions are as follows:

- Primary: How can we demonstrate and possibly measure the social impact that creative hubs have on their members and wider communities?
- Secondary: What is the general landscape of creative hubs in the Philippines?

This is in connection to the British Council's work on creative hubs, which aims to kickstart wider creative economy activities. Creative hubs also play a key role as safe spaces for creative expression, dialogue and innovation. The British Council defines creative hubs as:

"A creative hub is physical or virtual place that brings enterprising people together who work in the creative and cultural industries. Creative hubs are made up of many shapes and sizes, from buildings that house creative practitioners and businesses to temporary labs and incubation spaces which ignite innovations, as well as online networks that bring people together through an annual programme of events. Every creative hub is as unique as a fingerprint, as its model is determined by its geographic placement, cultural context, community requirements and unique funding model. Creative hubs have ultimately become 'nests for freelancers and micro SMEs to gather" (Prof. Andy Pratt: City, University of London).

The creative economy is of growing strategic significance in the Philippines, with increased governmental and municipal interest in developing and growing it and maximising its value to a range of agendas – such as for economic growth and competitiveness, inclusion and sustainability, and for creative city-making. This includes a focus on creative hubs, with a plethora of new hubs emerging over recent years. It also includes a range of cross-sector and spillover activities – such as for cultural tourism, wellbeing, heritage preservation, innovation through crafts and design, and soft power.

The British Council, working with local and UK research partner(s) would like to understand the profile, dynamics and impact of creative hubs in the Philippines and the role creative hubs play in creating/catalysing impact, including the impact they have on communities' social and creative development. While the impact of creative hubs is known and widely discussed, there is a lack of scientific evidence that focuses on the impact of specific hubs on their communities. Thus there is a lack of knowledge and appreciation of creative hubs from the local level to national government.

Overarching goals of the research include:

- Development of detailed data and knowledge on the social impact of creative hubs via two examples
- Development of a clear overarching perspective regarding the range, purpose and impact of creative hubs across the country
- A clear report with case studies on the role and impact of hubs and their potential for growth and innovation – as a basis to build understanding of the role and position of creative hubs for the creative economy and as enablers for social impact and inclusive growth (i.e. hubs for good)
- Advancement of the role of the British Council as a leader and enabler in this space (creative hubs for good)
- Development of new knowledge which can be used by other organisations who are in search of a way to quantify their impact (e.g. via social return). This may also be of value for hubs seeking to raise funding and build partnership
- Build professional relationships between researchers in the UK and Philippines
- Strong practical knowledge exchange at a policy, partnership and delivery level for the British Council SEA team and relevant stakeholders

Research tasks for this focus on creative districts in the Philippines includes:

This research will be accomplished through a collaborative activity between a UK and Philippine researcher/team. It will involve both in situ qualitative research and desk-based analysis from the hub database.

In situ qualitative research

A process of situation analysis will be undertaken with two hubs – Pineapple Lab and Anthill Fabric Gallery:

Pineapple Lab is a creative hub in Makati City that works a lot with LGBTQ and women groups, providing them a safe space for personal expression as well as business and project support. Research will explore and measure the role and impact of the hub on these groups. This includes a focus on the type of services and support provided, the networks and connections enabled, the influence of the hub for the wider creative ecosystem, and the lessons learned for other hubs.

Anthill Fabric Gallery, is a creative hub working with different artisan groups in Cebu and Northern Philippines to help increase their livelihood through craft. Cebu has played a dynamic role as a growing creative city in the Philippines. Research will explore and measure the role of the hub in supporting inclusive growth and social impact – e.g. building confidence, impacting on improved livelihoods, supporting marginal groups to participate, generating new and innovative products and services made by artisans.

The two case studies will be developed via interviews, workshops, analysis of the hub model, participant observation in hub activities, and, potentially, surveys with hub users. It will also involve interviews with hub management, partners and funders.

Knowledge generated here will be linked to the wider analysis of creative hubs in the Philippines (see below) – so the case studies can be positioned within an overall typology of hubs.

The assumption on the identified hubs is that they are available and eligible as case studies. Depending on the researchers and hubs' feedback, the identified case studies could still be modified.

Desk-based research and some qualitative engagement

Analysis of the existing database of 84 creative hubs that applied to British Council's Creative Innovators Programme. The database includes information on the hubs' mission and vision, size, programming, ambitions, opportunities and challenges. The methodology here can include analysis of applications (i.e. how hubs describe themselves), a follow-up survey and interviews. This process will generate the following:

- A typology of creative hubs by size, partnership and delivery model, and strategic purpose (e.g.
 for sector growth and innovation, visitor economy, real estate development / regeneration,
 education and culture development).
- An assessment of the role and purpose of creative hubs
- Mapping of the profile and scope of creative hubs from their inception to development. This is to understand their development pathway from the original concept to delivery.
- Modelling of good practice for creative hubs and development of a set of shared learning tools for SEA cities.
- Development of mini case studies and strategic assessments of up to 10 hubs, to include analysis
 of their social, cultural, and economic impact

Research outputs include:

- Development of detailed assessment of the role and impact of creative hubs in the Philippines, with two detailed case studies, a set of smaller case studies, and overall analysis and a typology (based on the database), in the form of:
 - A draft report, to which British Council will give feedback
 - A final report
- 2. Strong knowledge exchange and partnership within the Philippines and between the UK and the Philippines
- 3. New knowledge for PH-UK research team on effective creative hub models
- 4. Establishment / reinforcement of the British Council as a knowledge broker and leader in this field through the commissioning of high quality and relevant research
- 5. In addition, the British Council requires commitment for the researcher/s to participate in at least one sharing session of the report within the Philippines (travel costs excluded from project budget).

Research audience

Apart from the research being used for British Council's programme development, the research must be readable by the wider creative community, namely:

- · Government and policy makers
- Other researchers
- Other development organisations interested in creative economy
- Impact investors

Research format

The research format is not academic and writing style must be plain and direct to the point. The report must include (but are not limited to) the following sections:

- Executive summary
- Context
- Methodology
- · Presentation of data and analysis
- · High resolution visuals and images that will support key points
- · Recommendations

Working with a local researcher / expert

The UK researcher will be expected to work with a local Philippine researcher – as identified by the British Council. This will provide local expertise and capacity and set up the opportunity for knowledge exchange and mutual skills development. It is expected the local partner will form part of the overall research team with the UK researcher. The exact terms of the working relationship will be agreed as part of the research inception process.

Budget

The total budget for the local researcher is up to £7,000 or Php 450,000 (inclusive of VAT). This includes:

- Local researcher/team and report editing fees
- Related expenses such as communications and travel (to be arranged by the researcher in coordination with wider team)
- And other incidentals and expenses

The budget does not include:

- UK-based researcher fees
- Design, layouting and publishing of report. This will be led by the British Council.
- Costs related to research sharing sessions

8 Mandatory Requirements / Constraints

- 14.4 <u>Commercial Evaluation</u> Your "Overall Price" (as calculated in accordance with requirements of Annex 3 (Pricing Approach) for the goods and/or services will be evaluated by the evaluation panel for the purposes of the commercial evaluation. Prices must not be subject to any pricing assumptions, qualifications or indexation not provided for explicitly by the British Council as part of the pricing approach. In the event that any prices are expressed as being subject to any pricing assumptions, qualifications or indexation not provided for by the British Council as part of the pricing approach, the British Council may reject the full tender response at this point. The British Council may also reject any tender response where the Overall Price for the goods and/or services is considered by the British Council to be abnormally low following the relevant processes set out under the EU procurement rules. - 14.5 <u>Moderation and application of weightings</u> The evaluation panel appointed for this procurement will meet to agree and moderate scores for each award criteria. Final scores in terms of a percentage of the overall tender score will be obtained by applying the relevant weighting factors set out as part of the award criteria table above. The percentage scores for each award criteria will be amalgamated to give a percentage score out of 100.

The winning tender response – The winning tender response shall be the tender response scoring the highest percentage score out of 100 when applying the above evaluation methodology, which is also supported by any required verification evidence (to include, without limitation, any updated information or references relating to any Qualification Question responses) obtained by the Authority relating to any self-certification.
